### How many Model Portfolios are available?

Advisers have access to our ranges of model portfolios, our 'Ethical MPS' and 'Brighter World MPS'. Both sets of model portfolios are managed by the King & Shaxson Asset Management Investment Committee who meet on an ongoing basis.

### What are your management charges?

King & Shaxson's annual management charge starts from 0.20%. For our Ethical MPS, it is tiered based on the total AUM at a company level, (not just on an individual adviser basis). For our Brighter World MPS, the charge is a flat 0.20%.

### What other charges are applicable?

Additional costs include Fund OCFs and transactional charges which are available on the monthly factsheets. Performance data provided is net of these charges, as well as King & Shaxson's Annual Management Charge.

Platform/dealing charges vary between each platform, so please contact your platform provider.

### How can I access the portfolios?
